MEDICAL COUNCIL (RECOGNITION AND REGISTRATION) RULES 2020

The Medical Council, in exercise of the powers conferred on it by section 11 (as amended by section 81 of the Regulated Professions (Health and Social Care) (Amendment) Act 2020 (No. XX of 2020)) of the Medical Practitioners Act 2007 (No. 20 of 2007), hereby makes the following rules:-

PART 1

PRELIMINARY

Citation

1. These Rules may be cited as the Medical Council (Recognition and Registration) Rules 2020.

Commencement

2. These Rules come into operation on [XXXX] 2020.

Definitions

3. In these Rules, “Act” means the Medical Practitioners Act 2007 (No. 20 of 2007), as amended by the Health (Miscellaneous Provisions) Act 2007 (No. 42 of 2007), the Health (Miscellaneous Provisions) Act 2010 (No. 18 of 2010), the Medical Practitioners (Amendment) Act 2011 (No. 12 of 2011), the Health (Pricing and Supply of Medical Goods) Act 2013 (No. 14 of 2013), the Freedom of Information Act 2014 (No. 30 of 2014), the Health Identifiers Act 2014 (No. 15 of 2014), the Medical Practitioners (Amendment) Act 2017 (No. 10 of 2017), the European Union (Recognition of Professional Qualifications) Regulations 2017 (S.I. No. 8 of 2017) and the Regulated Professions (Health and Social Care) (Amendment) Act 2020 (No. X of 2020).

PART 2

REGISTER OF INTERNS

Information to be contained in register of interns

4. The Register of Interns shall contain, in respect of each registered intern, the following particulars:

- (a) name;
- (b) qualifications;
- (c) date(s) qualifications awarded;
- (d) registration number;
- (e) postal address for correspondence;

- (f) gender;
- (g) registration status (which may include particulars of any condition attached to registration or any undertaking given);
- (h) registration date; and
- (i) such other information as the Council, from time to time, considers appropriate.

Registration in register of interns

5. The period of internship referred to in section 36F(3) of the Act (in this Rule referred to as “the period”) must be a minimum of twelve months of supervised practice, to be completed consecutively, save where approved by the Council, and in accordance with guidelines issued by the Council in that regard.

PART 3

REGISTER OF MEDICAL PRACTITIONERS

Recognition of qualification as general qualification

6. (1) The examination referred to in section 44B(1)(b) of the Act is an examination which consists of both a test of clinical knowledge and a test of clinical skill, and, on the date of commencement of these Rules, the examination is referred to as the Pre-Registration Examination System (“the PRES”).

(2) The grounds, referred to in section 44B(1)(c) of the Act, on which a person with a qualification in medicine from a state other than the State (not being a qualification referred to in section 44B(2) of the Act) is exempted from the requirement to pass the PRES, are as follows:

- (a) that the person would be in a position to have his or her qualification in medicine recognised by the Council in accordance with section 44B(2) of the Act if he or she was an “eligible person” within the meaning assigned to that term in Regulation 3(1) of the Regulations of 2017, on the basis that he or she provides evidence of formal qualifications in basic medical training which would be recognised under Part 5, 7 or 14 of the Regulations of 2017;
- (b) that the person—
 - (i) has been awarded a postgraduate qualification which is—
 - (I) listed in Schedule 1, or
 - (II) in the opinion of the Council, at least equivalent to one or more of the qualifications listed in Schedule 1, and

- (ii) has completed—
 - (I) an internship of a minimum of one year supervised practise (to include at least two months in medicine and two months in surgery), or
 - (II) a minimum of two years in an accredited training programme;
- (c) that the person was registered on the General Register of Medical Practitioners under section 27 (full registration) or 29 (temporary registration) of the Medical Practitioners Act 1978 (No. 4 of 1978); or
- (d) that the person—
 - (i) has been granted a document which, in the opinion of the Council, is at least the equivalent of a certificate of experience on the basis that it—
 - (I) meets the standards published by the Council pursuant to section 88(3)(d) of the Act, and
 - (II) has been awarded following a period of employment in a hospital, health institution, clinic, general medical practice or other health service setting which provides, in the opinion of the Council, an equivalent standard of training to those hospitals, health institutions, clinics, general medical practices or other health service settings as are specified under section 36F(3)(b) of the Act.

Recognition of qualification as specialist qualification

7. The Council shall be satisfied that a person has achieved a standard which is adequate for recognition as a specialist qualification pursuant to section 44C(1)(a)(ii) of the Act where —

- (a) the Council determines the programme of training completed and experience in specialised medicine acquired by the person to be of a standard equivalent to that which would have caused a body referred to in section 44C(1)(a)(i) of the Act to have granted evidence of satisfactory completion of specialist training, or
- (b) the person would be in a position to have his or her qualification recognised under the Regulations of 2017 if her or she was an “eligible person” within the meaning assigned to that term in Regulation 3(1) of those Regulations, on the basis that he or she provides evidence of formal qualifications in specialist medical training which would be recognised under Part 5, 7 or 14 of the Regulations of 2017.

Details to be entered in register of medical practitioners

8. The register of medical practitioners shall contain, in respect of each registered medical practitioner, the following particulars:

- (a) name;

- (b) qualifications;
- (c) date(s) qualifications awarded;
- (d) registration number;
- (e) postal address for correspondence;
- (f) gender;
- (g) division of the register of medical practitioners in which the medical practitioner is registered, registration status and registration date;
- (h) registration status (which may include particulars of any condition attaching to the registration or any undertaking given);
- (i) registration date;
- (j) where the medical practitioner is registered in the Trainee Specialist Division and holds trainee specialist registration for the purposes of medical specialist training, the details of the individually numbered, identifiable post in which he or she is currently practising;
- (k) where the medical practitioner is registered in the Specialist Division, the specialties in respect of which the medical practitioner is registered;
- (l) where the medical practitioner is registered in the Visiting EEA Practitioners Division, the particulars of the temporary and occasional medical services being rendered and the period(s) in which the medical practitioner expects to render them; and
- (m) where the medical practitioner is registered in the Supervised Division, the individually numbered, identifiable post to which such registration applies.

Registration in Supervised Division

9. (1) The criteria referred to in section 50A(2)(b) of the Act to be met by medical practitioners seeking to be registered in the Supervised Division of the register of medical practitioners are the Level 1 and Level 2 assessments provided for in this Rule.

(2) For the purposes of paragraph (1), the Level 1 assessment is as follows:

- (a) verification of documentation; and
- (b) production of a declaration in the form provided in Schedule 2 demonstrating compliance with the requirements of section 50A(5) of the Act, signed by the chief executive officer (or equivalent) of the hospital or clinical site and the medical practitioner's clinical supervisor.

(3) Where any information on the declaration referred to in paragraph (2)(b) changes during a medical practitioner's registration in the Supervised Division of the register of medical practitioners, the medical practitioner shall inform the Council in writing and his or her employer shall provide to the Council an updated and signed declaration.

(4) For the purposes of paragraph (1), the Level 2 assessment comprises an examination which will assess general clinical knowledge.

(5) A medical practitioner may be considered for exemption from examination at Level 2 where he or she—

- (i) is eligible for registration in the General Division of the register under section 44B of the Act, or
- (ii) has obtained a qualification which is—
 - (I) listed in Schedule 3, or
 - (II) in the opinion of the Council, at least equivalent to one or more of the qualifications listed in Schedule 3.

Annual retention

10. (1) Registered medical practitioners wishing to continue their registration shall—

- (a) apply for retention of their name in the appropriate division of the register of medical practitioners annually by way of the relevant application form specified pursuant to section 107 of the Act, and
- (b) pay the relevant retention fees,

and the Council shall not consider an application for retention to be valid without completion of the relevant form and payment of the relevant fees.

(2) In accordance with section 36(1)(b) of the Act, the fees for retention on the register of medical practitioners shall be determined by the Council from year to year.

(3) An additional fee as may be specified by the Council from year to year shall become payable in respect of all applications under this Rule not submitted on or before 30 June in the relevant year.

(4) The Council shall only issue an annual registration certificate after receipt of a valid application under this Rule.

(5) In respect of all registered medical practitioners from whom a valid application is not received on or before 30 June, in addition to an additional fee becoming payable in accordance with paragraph (3), the Council may—

- (a) commence the process set out in section 79 of the Act to remove the registered medical practitioner from the register of medical practitioners, or

- (b) make a complaint to the Preliminary Proceedings Committee under section 57 of the Act in respect of a breach of the Act or these Rules.

Restoration to register following cancellation of registration

11. The criteria referred to in section 81(2)(d) of the Act, to be considered by the Council in deciding whether or not to restore the registration of a medical practitioner whose registration in the register of medical practitioners has been cancelled, are the following:

- (a) the circumstances that led to cancellation of the registration;
- (b) the findings of the Fitness to Practise Committee and the reasons relied on by the Council for its decision to cancel the registration;
- (c) whether the medical practitioner has gained any insight into the matters that led to cancellation of the registration;
- (d) what the medical practitioner has done since cancellation of the registration;
- (e) any adverse effect which the restoration of the medical practitioner to the register, with or without conditions, would have on public confidence and professional standards;
- (f) the steps taken by the medical practitioner to keep his or her medical knowledge and skills up to date;
- (g) the steps taken by the medical practitioner to rehabilitate since the cancellation of registration;
- (h) any evidence relevant to the medical practitioner's fitness to practise or practise of medicine; and
- (i) any other matter that the Council considers relevant to the consideration of the application for restoration to the register bearing in mind the object of the Council as set out in section 6 of the Act.

PART 5

LANGUAGE COMPETENCE

Language competence

12. A medical practitioner shall not be registered in the register of interns or the register of medical practitioners unless he or she provides, on request, acceptable evidence of language competence as determined by the Council from time to time and set out on the Council's website.
